AT THIS DAY CENTER 2,212 INDIVIDUALS, AVERAGING MORE THAN 100 PEOPLE PER DAY, WERE ABLE TO FIND RELIEF FROM THE WEATHER, HYDRATE, USE RESTROOMS, RECEIVE MAIL, AND MEET WITH ADVOCATES AND REPRESENTATIVES FROM PARTNER ORGANIZATIONS SUCH AS HEALTHCARE PROVIDERS, AGING SERVICES, PROBATION, HOUSING, AND OTHER SUPPORTIVE SERVICES.
